SESSION DESCRIPTION:

This session will provide an update to First Nations-in-Assembly on engagement work related to the development of Justice Canada's Indigenous Justice Strategy (IJS). In October 2023, the AFN held a Virtual Justice Speaker Series with intersectional discussions on themes including revitalization of First Nations legal traditions, reclamation of First Nations jurisdictions over justice systems, and First Nations legal traditions and the Canadian criminal justice system. The input from these engagements and the AFN's National Forum on Justice in 2022 has informed recommendations that the AFN will be submitting to Justice Canada on the IJS.
