Session Description:

This Dialogue Session will provide an overview of Economic Reconciliation advocacy including an update on work under the New Fiscal Relationship (NFR) between the Assembly of First Nations and the Government of Canada. This includes updates on recommendations under the 2019 Interim Report of the Joint Advisory Committee on Fiscal Relations, such as advancing the 10-Year Grant, modernization of the Indian Government Support Programs, and work to repeal the Default Prevention Management Policy and a mutual accountability framework, known as the National Outcomes Based Framework. In addition, the Dialogue Session will provide an overview of work towards economic reconciliation, including an update on recent Canada-led roundtables and the First Nation Procurement Organisation.
