CALL FOR PRESENTERS

The Assembly of First Nations (AFN) is pleased to announce the call for presentations for the AFN Nuclear Waste Management Forum “Navigating Nuclear Waste with Sovereignty and Self-Determination,” on May 26th and 27th, at The Ottawa Conference and Event Centre, in Ottawa, Ontario.

The AFN Nuclear Waste Management Forum is a platform for knowledge sharing, nation-to-nation dialogue, and collaborative decision-making on the critical issue of nuclear waste management. Grounded in the principles of sovereignty and self-determination, the forum emphasizes the protection of sacred water and lands while addressing the environmental, social, and legal dimensions of nuclear projects. Through discussions on Free, Prior, and Informed Consent (FPIC), First Nations Knowledge Systems, environmental stewardship, and policy frameworks, the event aims to strengthen First Nations’ capacity to assert their rights in decisions related to nuclear waste storage and transportation across Turtle Island.

The AFN is inviting dynamic speakers, presenters, and facilitators to submit a proposal to host a session at the forum on a diverse range of topics, such as:

- Free, Prior, and Informed Consent in Nuclear Development
- First Nations Knowledge Systems and Nuclear Stewardship
- Impact Assessments: Centering First Nations’ Voices
- Self-Determination and Sovereignty in Nuclear Waste
- Addressing long-term environmental risks of nuclear waste storage and transportation
- Nuclear Fuel Transportation: Risks and Preparedness
- Policy and Legal Frameworks: First Nations in the Nuclear Landscape
- Youth and Community Engagement in Resource Development
- Tools and strategies for building awareness and capacity at the community level
- Climate Change and Energy
- Protecting Sacred Sites and Waterways
- Alternative and Emerging Technologies for Nuclear Waste Management

All presentation timeslots are 60 minutes in length.
