## WHOLISTIC LONG-TERM AND CONTINUING CARE FRAMEWORK

#### **SESSION DESCRIPTION:**

The purpose of the dialogue session is to provide an update on the Assembly of First Nations (AFN) work on the development of a Wholistic Long-term and Continuing Care (LTCC) Framework through the reform of the Assisted Living (AL) and First Nations and Inuit Home and Community Care (FNIHCC) Programs, as mandated via AFN Resolution 44/2022, Co-development of Policy Options with Indigenous Services Canada for a Memorandum to Cabinet on the Wholistic Long-term and Continuing Care Framework.

First Nations-in-Assembly have called for the AFN to co-develop policy recommendations with Indigenous Services Canada (ISC) for a Wholistic LTCC Framework. The LTCC Framework aims to improve First Nations' ability to age comfortably in their homes and within their community. The key focus is ensuring First Nations have equitable access to long-term care services regardless of geographical location.

The dialogue session will also provide the following:

- · An overview of engagement to date.
- ISC's timelines for co-development.
- AFN Draft Resolution #05/23, Call for Extending Indigenous Services Canada's Timeline for Developing the Long-term and Continuing Care Framework.

The Technical Working Group on Social Development (TWGSD) and the Chiefs Committee on Health (CCOH) are proposing AFN Draft Resolution #05/23, Call for Extending Indigenous Services Canada's Timeline for Developing the Long-term and Continuing Care Framework to call upon ISC to extend the timelines to Winter 2024 and direct the AFN to facilitate culturally appropriate regional engagements to ensure properly informed policy recommendations are put forward. The goal is to encourage collaborative and dynamic discussions to help shape the future of the AL and FNIHCC programs to benefit First Nations.
