This session will provide an update on efforts to re-engage with Public Safety Canada on the co-development of a legislative framework recognizing First Nations Policing as an essential service and the advocacy around reaffirming First Nations inherent, Treaty and constitutional rights over policing. This session will also include updates on litigation files, including the status of the Indigenous Police Chiefs of Ontario's Canadian Human Rights Commission complaint and Federal Court order, the *Attorney General of Québec v. Pekuakamiulnuatsh Takuhikan* Supreme Court of Canada appeal, and the Association of First Nations and Inuit Police Directors of Quebec Canadian Human Rights Complaint.
