


# What did the CHRT change for children?

Over 2 million Jordan's Principle services An increase of 1.1 B in child and family services

23.4 B in compensation for victims

19.08 B in more services over the next 5 years. Not clear what happens in year 6

## Compensation: Next Steps

CHRT Determination of motion to CHRT to approve the Revised FSA

Caring Society, AFN and Canada

**Federal Court** 

Determination of motion to approve the Revised FSA (conditional on CHRT approval)

Class action parties (AFN/Moushoom) and Canada

Implementation and AFN and Canada drop appeals of CHRT compensation orders (conditional on CHRT and Fed. Court approval and ongoing Fed. Court supervision).

## Compensation: How you can help

#### Providing expert advice on how to best identify children:

Who were moved during a child welfare intervention

Placed in a kith placement off reserve

Between 2006-2022

Advice on supports to locate records and support beneficiaries

Educating and informing beneficiaries of their rights in a class action.

## AFN Resolution 2022/40 Long-term Reform

Requires no reduction in funding

Directs extension of negotiation timeframes

Requires evidence informed long-term reform proposals


Review by technical experts

FSA approval by Chiefs in Assembly

#### AIP Funds Secured by CHRT orders v. Remaining



Prevention funding: 2022 CHRT 8 para. 172 (7)(8)

"Canada shall fund the \$2500 per person resident on reserve and in the Yukon in total prevention funding in advance of the complete reform of the FNCFCS Program funding formulas, policies, procedures and agreements. Canada shall fund the \$2500 on an ongoing basis adjusted annually based on inflation and population until the reformed FNCFS Program is fully implemented."
