SESSION DESCRIPTION:

First Nations have a profound connection to the land, as it is central to all things. Canadian laws, policies, and programs must do more to support the return of First Nations lands, territories, and resources.

The Government of Canada has relied upon its Additions to Reserve (ATR) policy as authority for First Nations to add lands to their reserves. In his own words, however, Minister of Crown-Indigenous Relations Mark Miller admits that the (ATR) process is "largely broken, glacial in its pace, and a terrible way to get land back."

In 2022, the Government of Canada publicly acknowledged that "additions to reserve are an important part of advancing reconciliation" and committed to critical reform driven by First Nations. This Dialogue Session is intended to provide the first of many important opportunities for First Nations to participate in a critical conversation regarding what actions CIRNAC must take; what immediate reforms must be advanced; and how the federal policy must support First Nations goals and objectives to access and return lands to their communities.
