## UPDATE ON LONG-TERM REFORM OF THE FIRST NATIONS CHILD AND FAMILY SERVICES PROGRAM AND JORDAN'S PRINCIPLE: THE PATH FORWARD

### **SESSION DESCRIPTION:**

In this session, the Assembly of First Nations (AFN) will provide an update on the long-term reform of the First Nations Child and Family Services (FNCFS) Program and Jordan's Principle. Participants will receive an overview of the AFN and First Nations Child and Family Caring Society's (Caring Society) approach to long-term reform and receive an update on the progress of the First Nations-led research supporting evidence-based reform of FNCFS and Jordan's Principle.

In 2016, the CHRT found that Canada discriminated against First Nations children and their families in its provision and funding of the FNCFS Program and ordered Canada to immediately and completely overhaul the program. The CHRT also found that Canada discriminated against First Nations children and their families by applying a narrow definition of Jordan's Principle. In 2020, the AFN, Canada and other Parties entered intensive negotiations to finalize the matters of compensation and long-term reform of the FNCFS Program and Jordan's Principle, which resulted in an Agreement-in-Principle (AIP) on long-term reform in December 2021.

Negotiations for long-term reform have progressed since then and continue to be informed by feedback provided through regional engagements on long-term reform, and the Institute of Fiscal Studies and Democracy's (IFSD) research. In AFN Resolution 40/2022, *To Ensure Quality of Life to the First Nations Child and Family Services Program and Jordan's Principle*, First Nations-in-Assembly called for extended timeframes for negotiating long-term reform to ensure the development of evidence-based policy reforms for FNCFS and Jordan's Principle, and further called on Canada to uphold First Nations' rights to Free, Prior and Informed Consent. Pursuant to the calls of AFN Resolution 40/2022, the AFN and Caring Society collaborated on an approach to long-term reform for FNCFS and Jordan's Principle towards reaching an FSA.
