# **Backgrounder**

## **First Nation-led Impact Assessment**

### November 2024

This document has been prepared for information purpose to set the stage for the Assembly of First Nations' impact assessment webinar series. First Nations' participation in the webinars does not constitute consultation nor fulfilment of the Crown's duty to consult and accommodate with First Nations in regards to any project or assessment and should not be construed as such.

#### **BACKGROUND**

There are a growing number of First Nations leading their own assessments of major projects in their territories. First Nation-led assessments can inform whether a community provides or withholds free, prior and informed consent for a project and the *Impact Assessment Act* (IAA) requires the federal impact assessment to consider them along with other factors. Examples of First Nation-led assessments have been well documented and lessons articulated but there continues to be a need for dialogue amongst First Nations to share lessons learned from these processes.

One outstanding issue to be addressed is to need for adequate funding for First Nation-led assessments. The Impact Assessment Agency of Canada (IAAC) has indicated there is currently a small amount of funding available for First Nation-led assessments through an Indigenous Leadership in Impact Assessment Pilot Project.
