First Nations Leadership in Impact Assessment and Climate Action

Monday, December 2, 2024 • 10:30 AM - 12:00 PM • Room 102, Rogers Centre

Session Description:

This session will provide an opportunity to inform First Nations-in-Assembly on the proposed resolutions and key activities related to First Nations leadership in impact assessment.

The session will begin with remarks from Yukon Regional Chief Kluane Adamek (Environment Portfolio Holder), followed by a dedicated discussion on federal and First Nation-led Impact Assessment. The Impact Assessment Agency of Canada will speak to their review of the Physical Activities Regulation (Project List) and the ongoing work to adopt regulations and a policy approach to enable Indigenous Co-Administration Agreements. The AFN will provide an update on related work, including a summary of technical recommendations related to the two initiatives. AFN staff will provide a technical review of Draft Resolution 01/2024, *First Nations Leadership in Impact Assessment*, to inform dialogue and discussions during the Assembly.
