The National Forum will feature plenary sessions and facilitated discussions focused on the implementation of the United Nations Declaration on the Rights of Indigenous Peoples and will discuss best practices and strategic approaches to advancing First Nations' rights.

#### Forum topics may include:

- Implementation of the UN Declaration, covering Canada's Action Plan, British Columbia's DRIPA legislation, and the UNDA's impact
- Free, Prior, and Informed Consent (FPIC)
- · First Nations human rights in domestic and international fora
- Inherent rights, including self-government, self-determination, and sovereignty
- Obligations surrounding the duty to consult and accommodate
- · Engagement expectations for First Nations leaders, communities, and government partners

The AFN expects 400 attendees at the Forum, including First Nations Chiefs and Councilors, reepresentatives from First Nations organizations and technicians and governmental and non-governmental representatives.
