### Background


- At COP 15, hosted in December 2022, Canada committed to the Kunming-Montreal Global Biodiversity Strategy (KMGBF).
- KMGBF requires signatories to update:
  - National Biodiversity Strategy
  - $\circ$  Action Plan
  - Among others





### Background

- Following COP 15's KMGBF, Canada has committed to actioning work on biodiversity loss through:
  - $\circ~$  23 Targets to achieve by 2030
  - $\circ$  4 Goals to achieve by 2050
- Drafting the '2030 National Biodiversity Strategic Action Plan' (NBSAP), or 'National Biodiversity Strategy', was led by Environment and Climate Change Canada (ECCC).





### **Priority Targets**

- The scale of the NBSAP necessitates bundling – Canada created 3 themes to target bundles
- Reducing threats to biodiversity
  - Targets 1 8

Reducing threats to biodiversity Meeting People's needs through sustainable use and benefit sharing

  - Targets 9 13

#### **First Nations Engagement**

- During drafting phases of the NBSAP, AFN Environment conducted a virtual engagement session with First Nations to identify concerns with content.
- Through engagement sessions, and input from related First Nations-led fora, the AFN submitted 4 key recommendations to strengthen the NBSAP.

### **AFN NBSAP Contributions**

- 1. The inclusion of specific language referencing First Nations' rights and culture in relation to land, water, ice, and biodiversity.
- 2. The need for transformative change: targets currently uphold systemic colonial processes, and would maintain this status quo if unchanged.

### **AFN NBSAP Contributions**

- 3. Current policies, programs, and initiatives are insufficient to achieve targets and halt biodiversity loss - systemic change and policies disruptive to the colonial system are needed.
- 4. Need for full and effective First Nations participation: progressive language and intentions fall short without thorough involvement of First Nations in the planning and implementation of the NBSAP.

### **AFN NBSAP Contributions**

- In addition to recommendations and guided by the concerns and values shared by First Nations, AFN authored a First Nations' section to the NBSAP.
- This section highlighted the concerns and recommendations from First Nations, ensuring its inclusion in the final draft of the NBSAP.





## **NBSAP Challenges**

#### Valuing Biodiversity

People and businesses must prioritize nature, biodiversity, and sustainability in decisionmaking

#### **Mechanisms for Indigenous Leadership**

There remains a need for concrete mechanisms for Indigenous People to participate and contribute to Canada's NBSAP, enabling stewarding of nature

Includes area-based conservation mechanisms, such as mechanisms to enshrine Indigenous protected and conserved areas within western legislative and legal frameworks



### **NBSAP Challenges**

#### **Climate change exacerbates biodiversity loss**

Causing ecosystem degradation, loss

Directly driving down biodiversity

#### **Resources and whole-of-government approach**

Multi-jurisdictional collaboration, financial capacity, closing knowledge and data gaps



### Bill C-73 Nature Accountability Act


- Concurrent with the NBSAP, Canada announced its intentions to advance Bill C-73 to strengthen reporting requirements for the NBSAP.
- C-73 was structured as the supporting framework to NBSAP targets:
  - KMGBF is the Why
  - NBSAP is the **How**
  - C-73 was the legislative backing






### Bill C-73 Nature Accountability Act

- Despite lack of strength in the commitments as introduced, C-73 was strenuously debated at the Standing Committee on Environment and Sustainable Development (ENVI).
- Bill C-73 did not proceed past ENVI pre-study and died following prorogation of parliament.
  - Could be reintroduced (unlikely), but similar obstacles remain.







#### **Path Forward**


- Unclear picture of how Canada intends to implement its NBSAP.
- Fiscal restraint will impact Action Plan progression.
- Enhanced Nature Legacy, the mechanism for much of Canada's conservation portfolio, is in a period of renewal.





#### **Path Forward**

- The NBSAP remains Canada's guide to conservation into the future;
  - This entails recognition of First Nations and Indigenous Peoples as critical partners and leaders in conservation.
- AFN Environment will be working with select departments in the GoC to develop funding placemats outlining existing program and related funding opportunities as well as those stemming from renewal process.
