## Dialogue Session

### First Nations' Border Mobility Rights

*Monday, December 2, 2024 • 10:30AM – 12:00 PM • Room 201, Rogers Centre*

#### Session Description:

This dialogue session examines First Nations border mobility rights, looking at recent efforts by Immigration, Refugees and Citizenship Canada (IRCC) and the Canada Border Services Agency (CBSA) to address some of the complex challenges surrounding border mobility for First Nations peoples. It will also provide an update on current AFN advocacy and technical work to support First Nations border mobility rights, including a draft resolution mandate being considered by First Nations-in-Assembly.

Article 36 of the United Nations Declaration on the Rights of Indigenous Peoples articulates the minimum standards under international law for First Nations cross-border mobility rights. The Jay Treaty further recognizes First Nations mobility rights. Despite this, there remain a range of complex challenges surrounding border mobility for First Nations peoples.

First Nations leadership and technicians are invited to attend this Session and provide feedback on the federal approach to border mobility, sharing their experiences on border rights, ID challenges, and the impact of existing border policies.
